INCENTIVES & RESOURCES

SCVEDC helps businesses discover local, state and federal tax credit and cost saving programs, and resources for hiring, upskilling, and other business support services in SCV.

LA COUNTY CONNECT

Connecting LA County officials with developers to quickly address issues around permitting, fire and safety, or other barriers to project completion.

SO CAL EDISON

Helped SCV companies with issues around electrification, Public Safety Power Shutoffs (PSPS), fire mitigation plans and more.

AEROSPACE & DEFENSE FORUM

The A&D Forum community consists of industry senior executives and professionals who share news, information and analysis through their website and monthly chapter meetings.

AJCC JOB FAIRS

SCVEDC assisted companies with both layoff aversion and job fairs in cases of employee reduction, acting to coordinate meetings with talent and potential employers.

COVID 19 RESPONSE



2020 was a year of unprecedented challenges for businesses. SCVEDC quickly pivoted to offer support to companies as they navigated unique issues specific to the COVID-19 pandemic.

- SCVEDC assisted Henry Mayo Urgent Care in connecting with companies who want to establish testing programs for employees.
- SCVEDC partnered with the City of Santa Clarita to extend COVID Relief Grants to businesses in unincorporated Los Angeles County.


